Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. GradBridge has no affiliates.		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. GradBridge does not share with nonaffiliates so they can market to you.		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. GradBridge may jointly market with referral and lending partners.		

Other important information

GradBridge may share your information with service providers, referral partners, sponsor banks, or your school to provide and manage financial services. We do not sell personal information.
